



GRANTEE SPOTLIGHT: HER INITIATIVE Dar es Salaam, Tanzania

Women First's grantee partner Her Initiative connects young women with entrepreneurship skills training and opportunities. In Tanzania, unemployment remains a major challenge and more and more young people – especially young women – are finding it nearly impossible to find a secure footing in the labor market.

Made up of ambitious, energetic young women, Her Initiative uses social media as a strategy for connecting with their community, collaborating with stakeholders, and seeking sponsors and volunteers. Knowing that practical business skills and ongoing mentorship for young women are crucial, they engaged with Instagram accounts of successful business women in Dar es Salaam and sent them direct messages through the app.

That strategy resulted in a group of fantastic volunteer trainers who spend 3-4 hours every Saturday for 8 weeks offering advice on how to get started in seeking employment and becoming entrepreneurs by sharing their past mistakes, coaching young women on how to negotiate for better market prices and, most importantly, how to get through unexpected financial crisis' when all paths appear to be impossible to succeed.

Her Initiative is a perfect example of how women reach out to help other women and their communities. Lydia, the Founder and Executive Director of Her Initiative, is just 27. With the support of Women First, the young women of Her Initiative are pulling their peers up with them, while the generation of women above them make time in their busy schedules to mentor them. Women First is especially proud to be on the journey with Her Initiative as their first major funder and partner.


